Temporary road closure along NPC settlement road.

The Secretary for Infrastructure gives notice on the following, in accordance to section 13 of the Naoero Roads Act 2017.

Notice is to advise the people living within the NPC road vicinity starting from Quinton Alona's residence to old NPC batching plant road and the general public, that there will be a temporary closure of the road for road repairs.

The project consists of 2 phases as detailed hereunder:

- 1) First phase is the reconstruction of the road starting from the batching plant road to Frankie Amram's residence.

Commencement date: Monday 10th August 2020

Timeframe: estimated 1 month

Full closure

- 2) Second phase will commence after the first phase. Second phase will start from where the first phase ends for another 60 metres upwards just past Quinton Alona's residence.

Commencement date: Estimated Monday 7th September 2020

Timeframe: estimated 1 month

Full closure

It is therefore sought from the public to keep clear from the area to enable the construction to effectively achieve its goal. People living in the vicinity are asked to arrange alternate parking area for the duration of the project.
