1 Meeting of House

A quorum not being present, the Hon Godfrey Thoma (Speaker of Parliament) adjourned the House until Thursday 10am 2 May 2013 after reading prayers and making the following statement:

Omo iJORAN, I've been advised that there is no quorum in the House. Therefore I have a very short message to deliver this morning that I shall read, I will say it Nauruan for the benefit of our people who are listening.
