1 Meeting of House

A quorum not being present, Hon Godfrey Thoma (Speaker of Parliament) stated that he would take the Chair at 3pm.

A quorum not being present, the Hon Godfrey Thoma (Speaker of Parliament) adjourned the House after making the following statement.
